Haitians keep arriving at US-Mexico border

TIJUANA, Mexico (AP)

A crowd of about 1,000 Haitians shouted and shoved at the door of Mexico's immigration agency at the U.S. border, which has found itself an unhappy gateway for thousands of would-be migrants in recent months hoping to cross into the United States.

They wrapped their arms around the waists of people in front of them to prevent anyone from cutting in line in their desperation for one of just a few dozen slots granted daily with U.S. immigration authorities about a half-mile away.

Several thousand Haitians have traveled to Tijuana in recent months, overflowing migrant shelters and often sleeping outside next to their backpacks on sheets of cardboard, many after traveling 7,000 miles (11,000 kilometers) by foot, taxi and bus from Brazil through eight nations to the threshold of the United States. There have been so many that in August, Mexican authorities imposed a

system of appointments in order to keep the Haitians away from the flow of other visitors at one of the world's busiest border crossings.

Most of the Haitians appear unaware that the trip, and the desperate scramble at the border, has been in vain.

The U.S. Department of Homeland Security on Sept. 21 began putting Haitians in detention facilities before attempting to send them back to the homeland

they fled, a departure from previous practice of freeing them on humanitarian parole. The U.S. softened its posture after Haiti's 2010 earthquake but now treats them like people from other countries.

Many of the Haitians continuing to arrive in Tijuana have said they were unaware of the change, while those who knew about it said turning back was not an option. Brazil opened its doors to the Haitians after the earthquake devastated their impoverished country, but the South American country later developed its own economic problems, recently prompting many to seek work in the United States.

Antonio Juneiro, 40, is typical. He lived in Sao Paulo for four years until factory work dried up and he decided to join family in Miami. After spending \$4,000 to reach Tijuana, the prospect of a job in the United States was worth the risk of getting deported to Haiti.

"When you have money, you have hope. You have health," Juniero said at the Padre Chava migrant shelter in Tijuana, where he lived for a month while awaiting his appointment at San Diego's San Ysidro port of entry.

The exodus from Brazil accelerated in May and has shown no sign of slowing. U.S. officials say about 5,000 Haitians showed up at San Ysidro from October 2015 through late last month, and Immigration and Customs Enforcement Director Sarah Saldana said at a recent congressional hearing that officials told her on a trip to Central America that 40,000 more were on their way. Mexico's National Human Rights Commission said this week that an average of 300 Haitians and Africans were crossing Mexico's southern border daily.

With hundreds, perhaps thousands, of Haitian men, women and young children regularly spending the night just outside the busiest United States border crossing, Mexican officials have moved to bring some order to the unruly scene by granting 20-day permits to stay in Mexico while also helping schedule their slots with the Americans on the other side.

Mexico also extends the 20-day permits to smaller numbers of U.S.-bound immigrants from Ghana, Senegal and other African countries.

Clinton expands into GOP strongholds; Trump claims fraud

WHITE PLAINS, New York (AP)

With Donald Trump's path to electoral victory appearing increasingly narrow, Hillary Clinton is confidently advancing into states the Democrats haven't won in decades, as Trump attempts to focus attention on new allegations about the investigation into her email.

Clinton's campaign has launched new efforts aimed at expanding her lead and helping her party win back control of Congress.

There's a new \$2 million push in Arizona, aides said Monday, including a campaign stop in Phoenix by first lady Michelle Obama, one of Clinton's most effective surrogates. An additional \$1 million is going into efforts in Missouri and Indiana, both states with competitive Senate races, and a small amount of TV time is being bought in Texas and media appearances are scheduled in Utah.

At the same time Clinton is showing new signs of confidence, she faced fresh revelations about her use of a private email

server as secretary of state and hacked emails from a top campaign official's personal account. FBI records released Monday show that a senior State Department official unsuccessfully sought to lower the classification level of an email found on the server.

At an evening rally in Green Bay, Wisconsin, Trump labeled the move "collusion" and declared it even worse than Watergate.

"This is one of the great miscarriages of justice," he said, "in the history of our country."

As Trump kept up the criticism, Clinton's team was looking for ways to press her advantage.

With her lead increasing, Clinton is unlikely to need any of the normally solid-red states to win the White House. But her team believes that a wide presidential margin of victory would help end Trump's political movement and undermine his intensifying claims that the election is rigged.

Trump kept up his rhetoric about the legitimacy of the election system. In a Monday morning blitz of tweets, he lashed out at Republicans who have tried to tone him down, calling his own party's leaders "so naive" and claiming without evidence that major fraud is real.

There is no evidence to back up Trump's claims about the integrity of the U.S. voting system. A study by a Loyola Law School professor found that out of 1 billion votes cast in all American elections between 2000 and 2014, there were only 31 known cases of impersonation fraud.

\$25 million grant to improve student success in higher education

Washington State University Tri-Cities recently received a \$25 million seven-year GEAR UP grant to prepare students in low-income schools to enter and succeed in post-secondary education.

The Gaining Early Awareness and Readiness for Undergraduate Programs project will hire close to 100 new employees to work with students in middle schools.

This is the seventh U.S. Department of Education GEAR UP grant received by WSU Tri-Cities since 2002. Earlier awards have helped the university serve more than 25,000 students in middle and high schools.

The grant goals are to improve academic performance, completion of rigorous courses, knowledge of financial aid and post-secondary education, on-time graduation and post-secondary enrollment.

The grant “will raise student aware-

ness and readiness for post-secondary education and career opportunities,” said Chuck Hallsted, GEAR UP director. “It will really make a difference in our communities, especially for first generation and underrepresented populations.”

The program serves 4,500 students in 10 partner districts: Walla Walla, College Place, Dayton, Prescott, Touchet, Kennewick, Othello, Warden, Moses Lake and Soap Lake.

WSU Tri-Cities GEAR UP staff will assist students beginning in the sixth and seventh grades in the districts’ 14 middle schools. Staff will follow the stu-

dents through high school and into their first year of post-secondary education, which includes four-year colleges, community colleges and vocational technology schools.

Staff will serve students via in-class tutoring, mentoring, college trips, career

exploration, after school programs, summer programs, technology, skill development for success and professional development for teachers.

Staff will work collaboratively with school district partners to ensure an effective team approach, Hallsted said.

New documentary spotlights Latino voting rights advocate

ALBUQUERQUE, N.M. (AP)

Willie Velasquez isn't as well-known as other Latino activists like Cesar Chavez, Dolores Huerta and Rodolfo "Corky" Gonzales.

But according to a new VOCES/PBS documentary, he was a key figure in developing the Latino voting bloc years before it became the nation's largest minority group and before both parties actively sought Latino voters' support.

Latino Public Broadcasting's "Willie Velasquez: Your Vote Is Your Voice" aims to bring attention to the voting rights advocate who came from San Antonio's poor west side and ended up rubbing elbows with the likes of President Ronald Reagan and Sen. Ted Kennedy. He persuaded Republicans in the 1970s and '80s to reach out to Hispanics because of the growing Latino voter-registration numbers in swing districts.

Velasquez might have done even more to foster Hispanic political power if not for his sudden death at age 44.

"It feels like I've been working on his story for 30 years," said director Hector Galan, who interviewed Velasquez in 1983 at the height of his popularity in Texas. "And here it is."

An early protégé of the late U.S. Congressman Henry B. Gonzalez, a young Velasquez was mentored by the generation of Mexican-American activists who helped elect President John F. Kennedy. Velasquez saw how poll taxes and voter intimidation kept Mexican-Americans from the polls and sought to change that.

But Velasquez soon got swept up in the farmworkers movement in California led by Chavez and Huerta. He also became captivated by the radical Chicano Movement until leaders opted to form an ethnic-based political party called La Raza Unida.

Velasquez left organized politics and started the nonpartisan, nonprofit Southwest Voter Registration Education Project. The group's goal: register as many Latinos to vote as possible in Texas, New Mexico, Arizona, California and Colorado.

On a shoestring budget, Velasquez and

his army of recruits went door-to-door to register Hispanics to vote despite efforts by local authorities and threats of violence to stop them. The group was one of the first to use technology to tally up registration rolls to keep track of potential political power in small towns and cities. That use of computers caught the attention of candidates searching for ways to attract new voters.

"It's an IBM," Velasquez bragged to a reporter on the technology the group used. "It isn't a Mexican computer."

By 1978, Sen. John Tower, the first Republican U.S. senator from Texas since Reconstruction, was engaging with Velasquez and cut a Spanish-language commercial that earned him 37 percent of the Latino vote. Former California Gov. Ronald Reagan and former Massachusetts Gov. Michael Dukakis soon contacted Velasquez during their bids for the U.S. presidency.

In addition, San Antonio elected Henry Cisneros, the city's first Hispanic mayor since 1835.

Velasquez realized early on that the only way for Latinos to gain political power was through the ballot box, Galan said.

In 1988, he was diagnosed with cancer. He had no health insurance, and doctors gave him less than four months to live. He lasted four weeks.

Lorenzo Cano, associate director of the Center for Mexican-American Studies at the University of Houston, said Velasquez influenced generations of activists who followed the idea of voting as power.

Richard Sherman's tirade overshadows Seattle's win

RENTON, Washington (AP)

In the future, Seattle coach Pete Carroll would prefer if Richard Sherman handled his frustrations in a way that did not result in an emotional eruption on the sideline in the middle of a game.

Sherman's shouting match with players and coaches became a teaching moment for the Seahawks on Monday, a day after Seattle rallied for a 26-24 win over Atlanta.

Carroll spent most of his Monday availability talking about emotions, philosophy and what exactly transpired on Seattle's sideline that became as much of a story as the Seahawks improving to 4-1.

"What I told the guys today was there's going to always be things that happen and we're going to learn if we can from the experiences that we have and those that we draw from and get smarter and more aware, we're going to get better," Carroll said. "It wound up being an extraordinary positive for our team that we could hang through the rigors and

the challenges against a terrific team and find a way to win a football game."

Sherman's tirade happened after a

blown coverage in Seattle's secondary that allowed Julio Jones to run uncovered down the sideline for a 36-yard

touchdown in the third quarter. Sherman was livid, screaming at anyone within earshot on the sideline and getting in the face of anyone who tried to calm him down. Earl Thomas, Michael Bennett, Kam Chancellor and Bobby Wagner all took turns trying to calm Sherman with little success.

Carroll mostly stood back and watched how his players handled the situation.

"I thought it was a marvelous job of our guys showing who they are and their resolve to make sure they do what is right for our team," Carroll said. "It was impressive."

Seattle received mixed news on two injuries.

Bennett has a chance to play next week at Arizona after injuring his right knee on a cut block by Atlanta's Jake Matthews.

The news on Luke Willson wasn't as good. Carroll said Willson has cartilage damage and strained ligaments in his right knee that could require surgery. Willson was injured on Christine Michael's touchdown run in the fourth quarter that pulled Seattle within 24-23.

Dave Says

Selling a car with a lien

Dear Dave,

How do you sell a vehicle with a lien amount that's higher than the actual value of the car? — *Miranda*

Dear Miranda,

First, you have to find a way to cover the difference between the amount of the lien and what you can get for the car. Let's look at an example.

If the car is worth \$15,000, and you owe \$18,000, that would leave you \$3,000 in the hole. How do you get out of that car? The bank holds the title, and until you give them the payoff amount of \$18,000, you're not getting the title. The easiest and simplest way would be if you had \$3,000 on hand to make up the difference. But if someone comes along and buys the car from you for \$15,000, you've got to be able to cover the remaining \$3,000, right?

Barring the best-case scenario where you actually have the money, you could go to a local bank or credit union and borrow the remaining \$3,000. I hate debt, but being \$3,000 in the hole is a lot better than \$18,000 in the hole. Then, you could turn around and pay back the \$3,000 quickly.

After that, you'd give the total amount owed to the bank. They would give you the title, and you sign it over to the new owner. That's how it works! — *Dave*
